

with the recommendation that it be approved without amendment.



AN ACT SEPARATING THE ANTIPOLLO NATIONAL HIGH SCHOOL –
CUPANG ANNEX IN BARANGAY CUPANG, CITY OF
ANTIPOLLO FROM THE ANTIPOLLO NATIONAL HIGH SCHOOL,
CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH
SCHOOL TO BE KNOWN AS CUPANG NATIONAL HIGH
SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Separation and Conversion into a National High School.*
2 – The Antipollo National High School – Cupang Annex in Barangay Cupang,
3 City of Antipollo is hereby separated from the Antipollo National High School
4 and converted into an independent national high school to be known as Cupang
5 National High School.

6 SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,
7 liabilities and records of the Antipollo National High School – Cupang Annex
8 are hereby transferred to and absorbed by the Cupang National High School.

9 SEC. 3. *Appropriations.* – The Secretary of Education shall
10 immediately include in the Department's program the operationalization of the

1 Cupang National High School, the initial funding of which shall be charged .
2 against the current year's appropriations of the Antipolo National High School
3 – Cupang Annex. Thereafter, the amount necessary for the continued
4 operation of the school shall be included in the annual General Appropriations
5 Act.

6 SEC. 4. *Implementation.* – The Secretary of Education shall issue rules
7 and regulations that may be necessary to carry out the purpose of this Act.

8 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
9 its publication in the *Official Gazette*.
