

The Committees on Education, Arts and Culture and on Finance to which was referred House Bill No. 5144, introduced by Reps. Gatlabayan, De Guzman, and Lagman, entitled:


"AN ACT


SEPARATING THE ANTIPOLO NATIONAL HIGH SCHOOL - MAXIMO L. GATLABAYAN ANNEX IN BARANGAY SAN JOSE, CITY OF ANTIPOLO FROM THE ANTIPOLO NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS MAXIMO L. GATLABAYAN NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR"

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. On line 2 of page 1, delete the words "Maximo L. Gatlabayan" and in lieu thereof insert the word "Paenaan";
2. On line 5 of the same page, between the words "Gatbalayan" and "National" insert the word "Memorial";
3. On lines 7 to 8 of the same page, delete the words "Maximo L. Gatlabayan" and in lieu thereof insert the word "Paenaan";
4. On line 3 of page 2, between the words "Gatbalayan" and "National" insert the word "Memorial";
5. On line 5 of the same page, delete the words "Maximo L. Gatlabayan" and in lieu thereof insert the word "Paenaan"; and
6. On the title of the bill delete the words "MAXIMO L. GATLABAYAN" and in lieu thereof insert the word "PAENAAN"; and between the words "GATLABAYAN" and "NATIONAL" insert the word "MEMORIAL" so that the title shall now read: "AN ACT SEPARATING THE ANTIPOLO NATIONAL HIGH SCHOOL- PAENAAN ANNEX IN BARANGAY SAN JOSE, CITY OF ANTIPOLO FROM THE ANTIPOLO NATIONAL HIGH SCHOOL CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS MAXIMO L. GATLABAYAN MEMORIAL NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR"







AN ACT SEPARATING THE ANTIPOLO NATIONAL HIGH SCHOOL --
MAXIMO L. GATLABAYAN ANNEX IN BARANGAY SAN JOSE,
CITY OF ANTIPOLO FROM THE ANTIPOLO NATIONAL HIGH
SCHOOL, CONVERTING IT INTO AN INDEPENDENT
NATIONAL HIGH SCHOOL TO BE KNOWN AS MAXIMO L.
GATLABAYAN NATIONAL HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

- 1 SECTION 1. *Separation and Conversion into a National High School.*
2 -- The Antipolo National High School -- Maximo L. Gatlabayan Annex in
3 Barangay San Jose, City of Antipolo is hereby separated from the Antipolo
4 National High School and converted into an independent national high school
5 to be known as Maximo L. Gatlabayan National High School.
- 6 SEC. 2. *Transfer of Assets and Liabilities.* -- All personnel, assets,
7 liabilities and records of the Antipolo National High School -- Maximo L.
8 Gatlabayan Annex are hereby transferred to and absorbed by the Maximo L.
9 Gatlabayan National High School.

1 SEC. 3. *Appropriations.* – The Secretary of Education shall
2 immediately include in the Department’s program the operationalization of the
3 Maximo L. Gatlabayan National High School, the initial funding of which shall
4 be charged against the current year’s appropriations of the Antipolo National
5 High School – Maximo L. Gatlabayan Annex. Thereafter, the amount
6 necessary for the continued operation of the school shall be included in the
7 annual General Appropriations Act.

8 SEC. 4. *Implementation.* – The Secretary of Education shall issue rules
9 and regulations that may be necessary to carry out the purpose of this Act.

10 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
11 its publication in the *Official Gazette*.
