



AN ACT CONVERTING THE TAGKAWAYAN MUNICIPAL HIGH SCHOOL IN THE MUNICIPALITY OF TAGKAWAYAN, PROVINCE OF QUEZON INTO A NATIONAL HIGH SCHOOL TO BE KNOWN AS TAGKAWAYAN NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Conversion into a National High School.* — The
2 Tagkawayan Municipal High School in the Municipality of Tagkawayan,
3 Province of Quezon is hereby converted into a national high school to be
4 known as Tagkawayan National High School.

5 SEC. 2. *Transfer of Assets and Liabilities.* — All personnel, assets,
6 liabilities and records of the Tagkawayan Municipal High School are hereby
7 transferred to and absorbed by the Tagkawayan National High School.

8 SEC. 3. *Appropriations.* — The Secretary of Education shall
9 immediately include in the Department's program the operationalization of the
10 Tagkawayan National High School, the initial funding of which shall be

1 charged against the current year's appropriations of the Tagkawayan Municipal
2 High School. Thereafter, the amount necessary for the continued operation of
3 the school shall be included in the annual General Appropriations Act.

4 SEC. 4. *Implementation.* – The Secretary of Education shall issue such
5 rules and regulations as may be necessary to carry out the purpose of this Act.

6 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
7 its publication in the *Official Gazette*.
