with the recommendation that it be approved without amendment.



AN ACT CONVERTING THE MAKIWALO INTEGRATED SCHOOL IN  
BARANGAY MAKIWALO, MUNICIPALITY OF MONDRAGON,  
PROVINCE OF NORTHERN SAMAR INTO A NATIONAL HIGH  
SCHOOL TO BE KNOWN AS MAKIWALO NATIONAL HIGH  
SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

- 1           SECTION 1. *Conversion into a National High School.* – The Makiwalo  
2 Integrated School in Barangay Makiwalo, Municipality of Mondragon,  
3 Province of Northern Samar is hereby converted into a national high school to  
4 be known as Makiwalo National High School.
- 5           SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,  
6 liabilities and records of the Makiwalo Integrated School are hereby  
7 transferred to and absorbed by the Makiwalo National High School.
- 8           SEC. 3. *Appropriations.* – The Secretary of Education shall  
9 immediately include in the Department's program the operationalization of the  
10 Makiwalo National High School, the initial funding of which shall be charged

1 against the current year's appropriations of the Makiwalo Integrated School.  
2 Thereafter, the amount necessary for the continued operation of the school  
3 shall be included in the annual General Appropriations Act.

4       SEC. 4. *Implementation.* – The Secretary of Education shall issue rules  
5 and regulations that may be necessary to carry out the purpose of this Act.

6       SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
7 its publication in the *Official Gazette*.
