

EXPLANATORY NOTE

In the past decades, development planning and development interventions in Mindanao were implemented in a fragmented manner. During that time, disintegrated and highly uneven development enveloped Mindanao as each region competed for scarce resources coming from Manila instead of complementing each other's economic strengths. Mindanao was also seen in the past as a mere supplier of food and raw materials to the factories and bourgeoning cities of Manila and Cebu.

There was no integrated development plan for the entire island. What was prevailing then were regional plans which promoted the economic development of each of the regions comprising Mindanao but not in their totality as an island economy.

There was no mechanism that consolidates and integrates peace and development efforts in the island region.

However, due to the formation of the BIMP-EAGA, Mindanao emerged as the front door of investments and trade to the East EAGA Region.

The integration of Mindanao, which was built when Mindanao Economic Development Council (MEDCo) was created, has proven that an integrated, holistic, and Mindanao-wide approach to developing Mindanao is far more effective than the usual national-led and region-centric approach, which was what Mindanao had in the 70s and 80s, and which only accentuated Mindanao's fragmentation. A Mindanao-wide agency that sees through implementation of this transformation process, looks beyond the regions and integrates all development efforts at a Mindanao-wide level cannot be overemphasized.

This bill seeks to address such need – to create a permanent institution that will ensure that the Mindanao's Agenda is within the prism of national government priorities.

Hence, an expeditious passage of the bill is earnestly sought.

AN ACT

CREATING THE MINDANAO ECONOMIC DEVELOPMENT AUTHORITY (MEDA), DEFINING ITS POWERS AND FUNCTIONS, AND PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enabled by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION. 1. *Title.* - This Act shall be known as the "Mindanao Economic
 Development Authority (MEDA) Act of 2009."

SEC. 2. Declaration of Policy. - It is hereby declared a policy of the State to 4 accelerate the socio-economic growth and development of Mindanao, by encouraging and 5 6 increasing trade, tourism and investments, encouraging private enterprise, and advancing efforts towards peace and development. Towards this end, an effective institutional mechanism 7 shall be established to address the need for a coordinative and integrative approach for the 8 formulation and implementation of various Mindanao-wide, Mindanao-specific interregional 9 development plans, programs and projects. The government shall furthermore undertake efforts 10 to promote the active participation of Mindanao and Palawan in the Brunei Darussalam-11 Indonesia-Malaysia-the Philippines - East ASEAN Growth Area (BIMP-EAGA). 12

14 SEC. 3. *Creation of the Mindanao Economic Development Authority*. - The 15 Mindanao Economic Development Authority, hereinafter referred to as the Authority, is hereby 16 created, which shall promote, coordinate, and facilitate the active and extensive participation of 17 all sectors to effect the socio-economic development of Mindanao. It shall also act as an

 including, but not limited to public-private partnership;
- (m) Review and recommend for approval by the NEDA Board such Mindanao-wide
 and Mindanao-specific inter-regional programs, projects, and plans by the national
 government and donor agencies subject to existing laws, rules and regulations;
- (n) Act as the official and permanent Philippine Coordinating Office for BIMP-EAGA
 (PCOBE) and as lead agency of the government in coordinating the formulation
 and implementation of policies and programs and monitoring of all activities
 related thereto;
- (o) Represent and strengthen the participation of the Philippine focus areas for BIMP EAGA which are Mindanao and Palawan;
- (p) Closely coordinate with the private sector in all policy deliberations concerning
 BIMP-EAGA;

19 SEC. 10. Executive Committee. - The Board shall constitute an Executive Committee, 20 hereinafter referred to as the ExeCom, from among its membership to act, for and on its behalf 21 when the Board is not in session, on urgent matters as may be deemed necessary by the 22 Chairperson. To ensure inter-regional representation and participation, the following shall 23 comprise the Execom:

24 (a) The MEDA Chairperson

25 (b) The Chairpersons of the RDCs and REDPB

- 26 (c) The Representative from the Mindanao Business Sector
- 27 (d) The Representative from the Mindanao Non-Government Organization (NGO)
 28 Sector.

1 The Executive Director, as the Board Secretary, shall provide technical assistance to the 2 ExeCom. 3 4 SEC. 11. BIMP-EAGA Advisory Board. There is hereby constituted a BIMP-EAGA Advisory Board to be composed of the following: 5 6 (a) MEDA Chairperson as Head; 7 (b) Chairpersons of the RDCs of Regions IX, X, XI, XII and XIII, and REDPB of ARMM; 8 (c) City Mayor of Puerto Princesa; 9 10 (d) Provincial Governor of Palawan; and, 11 (e) Two Philippine Country Representatives to the BIMP-EAGA Business Council 12 (BEBC). 13 The BIMP-EAGA Board shall convene, from time to time, to discuss issues and 14 recommend policies and programs to ensure the widest participation of Mindanao and Palawan 15 in the activities of BIMP-EAGA. It shall make recommendations to the Chairperson, being the Head of the PCOBE. The PCOBE, in consultation with the BIMP-EAGA Board, will draw up 16 17 its own procedures for making recommendations, finalizing decisions and overseeing implementation of BIMP-EAGA activities in Mindanao and Palawan. 18 19 SEC. 12. Organizational Structure. - The Chairperson shall determine the 20 organizational structure, staffing pattern, and pay scales of the Authority subject to existing 21 civil service and compensation laws. The Chairperson may reorganize the Authority and may 22 23 create or abolish divisions, units, or branches therein as the exigencies of the affairs of the 24 Authority may require. 25 26 SEC. 13. Transitory Provision - The Mindanao Economic Development Council

27 (MEDCo), created under Executive Order 512, and Executive Order 244, as amended, is28 hereby abolished.

2

The unexpended appropriations of the abovementioned agency are hereby transferred to MEDA including its existing records, properties, equipment, facilities and other assets.

The MEDA shall absorb the existing plantilla positions and incumbent staff of MEDCo who shall continue to perform their respective duties and responsibilities and receive the corresponding salaries and benefits, in the fulfillment of the powers and functions of MEDA.

SEC. 14. Appropriations.- The amount necessary to finance the initial implementation
of this Act shall be charged against the current year's appropriations of the Mindanao
Economic Development Council (MEDCo). Thereafter, the current budget shall be increased
by 100%, which amount shall be included in the Annual General Appropriations Act (GAA)
for its continued implementation.

12 The current appropriations of MEDCo shall be transferred to the Mindanao Economic
13 Development Authority to commence its activities.

14

15 SEC. 15. *Repealing Clause.* - All laws, decrees, executive orders, rules and 16 regulations, or parts thereof inconsistent with or contrary to the provisions of this Act are 17 hereby repealed or modified accordingly.

18

19 SEC. 16. Separability Clause. - If any part or provision of this Act is held 20 unconstitutional or invalid, other parts or provisions thereof, which are not affected, shall 21 continue to remain in full force and effect.

SEC. 17. *Effectivity*. - This Act shall take effect fifteen (15) days following completion
of its publication in at least two (2) newspapers of general circulation.
