MAJAYJAY, PROVINCE OF LAGUNA AND IN ALL ITS
BARANGAYS, TO BE KNOWN AS THE "MAJAYJAY DAY"

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. October 2 of every year is hereby declared an official
2 nonworking holiday in the Municipality of Majayjay, Province of Laguna and
3 in all the barangays therein to commemorate the foundation day of the
4 municipality, to be known as the "Majayjay Day".

5 SEC. 2. This Act shall take effect upon its approval.
