

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. September 18 of every year is hereby declared a special
2 nonworking holiday in the City of Bislig, Province of Surigao del Sur to
3 commemorate the signing of Republic Act No. 8804 declaring Bislig a city of
4 Surigao del Sur.

5 SEC. 2. This Act shall take effect upon its approval.
