
**MR. PRESIDENT:**







AN ACT DECLARING SEPTEMBER 29 OF EVERY YEAR AS A  
SPECIAL NONWORKING PUBLIC HOLIDAY IN THE  
MUNICIPALITY OF BALILIHAN, PROVINCE OF BOHOL

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. September 29 of every year is hereby declared as a special  
2 nonworking public holiday in the Municipality of Balilihan, Province of Bohol  
3 to commemorate its *Sumad* Day or foundation anniversary.

4           SEC. 2. This Act shall take effect fifteen (15) days from its publication  
5 in the *Official Gazette* or in at least two (2) newspapers of national circulation.

Approved,
