
**Mr. President:**

with the recommendation that it be approved without amendment.



AN ACT CONVERTING THE BANTUGAN HIGH SCHOOL IN  
BARANGAY BANTUGAN, MUNICIPALITY OF PRESENTACION,  
PROVINCE OF CAMARINES SUR INTO A NATIONAL HIGH  
SCHOOL TO BE KNOWN AS BANTUGAN NATIONAL HIGH  
SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Conversion into a National High School.* – The Bantugan  
2 High School in Barangay Bantugan, Municipality of Presentacion, Province of  
3 Camarines Sur is hereby converted into a national high school to be known as  
4 Bantugan National High School.

5           SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,  
6 liabilities and records of the Bantugan High School are hereby transferred to  
7 and absorbed by the Bantugan National High School.

8           SEC. 3. *Appropriations.* – The Secretary of Education shall  
9 immediately include in the Department's program the operationalization of the

1 Bantugan National High School, the funding of which shall be included in the  
2 annual General Appropriations Act.

3 SEC. 4. *Implementation.* – The Secretary of Education shall issue rules  
4 and regulations that may be necessary to carry out the purpose of this Act.

5 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
6 its publication in the *Official Gazette*.
