AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY
AGAY-AYAN, MUNICIPALITY OF TINAMBAC, PROVINCE OF
CAMARINES SUR TO BE KNOWN AS AGAY-AYAN NATIONAL
HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National High School.* — There is
2 hereby established, under the supervision of the Department of Education, a
3 national high school in Barangay Agay-ayan, Municipality of Tinambac,
4 Province of Camarines Sur to be known as Agay-ayan National High School.

5 SEC. 2. *Appropriations.* — The Secretary of Education shall
6 immediately include in the Department's program the operationalization of
7 Agay-ayan National High School, the funding of which shall be included in the
8 annual *General Appropriations Act*.

9 SEC. 3. *Implementation.* — The Secretary of Education shall issue such
10 rules and regulations as may be necessary to carry out the purpose of this Act.

11 SEC. 4. *Effectivity.* — This Act shall take effect fifteen (15) days after
12 its publication in the *Official Gazette*.
