



AN ACT CONVERTING THE AYANGAN NATIONAL HIGH SCHOOL IN  
BARANGAY PONGHAL, MUNICIPALITY OF LAGAWÉ,  
PROVINCE OF IFUGAO INTO A NATIONAL AGRICULTURAL  
AND VOCATIONAL HIGH SCHOOL TO BE KNOWN AS  
AYANGAN NATIONAL AGRICULTURAL AND VOCATIONAL  
HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Conversion into a National Agricultural and Vocational*  
2 *High School.* – The Ayangan National High School in Barangay Ponghal,  
3 Municipality of Lagawe, Province of Ifugao is hereby converted into a national  
4 agricultural and vocational high school to be known as Ayangan National  
5 Agricultural and Vocational High School.

6           SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,  
7 liabilities and records of the Ayangan National High School are hereby  
8 transferred to and absorbed by the Ayangan National Agricultural and  
9 Vocational High School.

1           SEC. 3. *Appropriations.* – The Secretary of Education shall  
2 immediately include in the Department's program the operationalization of the  
3 Ayangan National Agricultural and Vocational High School, the funding of  
4 which shall be included in the annual General Appropriations Act.

5           SEC. 4. *Implementation.* – The Secretary of Education shall issue such  
6 rules and regulations as may be necessary to carry out the purpose of this Act.

7           SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
8 its publication in the *Official Gazette*.
