Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Conversion into a National High School The Nato High
2	School in the Municipality of Sagñay, Province of Camarines Sur is hereby
3	converted into a national high school to be known as Nato National High
4	School.
5	SEC. 2. Transfer of Assets and Llabilities All personnel, assets,
6	liabilities and records of the Nato High School are hereby transferred to and
7	absorbed by the Nato National High School.
8	SEC. 3. Appropriations The Secretary of Education shall
9	immediately include in the Department's program the operationalization of the
10	Nato National High School, the funding of which shall be included in the
11	annual General Appropriations Act.
2	SEC. 4. Implementation The Secretary of Education shall issue rules
3	and regulations that may be necessary to carry out the purpose of this Act.
14	SEC. 5. Effectivity This Act shall take effect fifteen (15) days after
5	its publication in the Official Gazette.
