The Chief Justice of the Supreme Court, in coordination with 2 the Secretary of the Department of Justice, shall immediately include in the 3 Court's program the operationalization of the two (2) additional branches of 4 the Regional Trial Court in the Province of Leyte to be stationed at the City of 5 Tacloban, the funding of which shall be included in the annual General 6 Appropriations Act.

SEC. 3. Section 14(i) of Batas Pambansa Blg. 129, otherwise known
as "The Judiciary Reorganization Act of 1980", as amended, and all other
laws, rules and regulations which are inconsistent with this Act are hereby
amended, repealed or modified accordingly.

SEC. 4. This Act shall take effect fifteen (15) days after its complete
publication in the *Official Gazette* or in two (2) newspapers of general
circulation.
