AN ACT ESTABLISHING THE MARIVELES DISTRICT HOSPITAL IN THE MUNICIPALITY OF MARIVELES, PROVINCE OF BATAAN AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. There is hereby established, under the supervision of the
- 2 Department of Health, a fifty (50)-bed capacity district hospital in the
- 3 Municipality of Mariveles, Province of Bataan to be known as the Mariveles
- 4 District Hospital.
- 5 SEC. 2. The Secretary of Health shall immediately include in the
- 6 Department's programs the operationalization of the Mariveles District
- 7 Hospital, the funding of which shall be included in the annual General
- 8 Appropriations Act.
- SEC. 3. This Act shall take effect upon its approval.
   Approved,
