



APPROPRIATING FUNDS THEREFOR"**



AN ACT PROVIDING FOR THE UPGRADE AND MODERNIZATION AS
WELL AS INCREASING THE BED CAPACITY OF SEVERO
VERALLO MEMORIAL DISTRICT HOSPITAL AT TAYTAYAN,
CITY OF BOGO, PROVINCE OF CEBU FROM FIFTY (50)- TO
ONE HUNDRED (100)-BED CAPACITY AND APPROPRIATING
FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Severo Verallo Memorial District Hospital in
2 Taytayan, City of Boggo, Province of Cebu is hereby modernized and upgraded
3 from a fifty (50)-bed capacity secondary hospital into a one hundred (100)-bed
4 capacity, which shall be under the direct technical operation and administration
5 of the Department of Health.

6 SEC. 2. The Department of Health shall issue and promulgate such
7 rules and regulations as deemed necessary for the evaluation, approval and
8 implementation of this Act.

9 SEC. 3. The increase in the bed capacity of the Severo Verallo
10 Memorial District Hospital from fifty (50) to one hundred (100) beds shall be

1 implemented for a period of not more than two (2) years from the approval of
2 this Act.

3 SEC. 4. The Secretary of Health shall immediately include in the
4 Department's programs the operationalization of the Severo Verallo Memorial
5 District Hospital, the funding of which shall be included in the annual General
6 Appropriations Act.

7 The local government unit concerned shall continue to provide funding
8 for the Severo Verallo Memorial District Hospital until such time that the same
9 is funded in the annual General Appropriations Act.

10 SEC. 5. This Act shall take effect fifteen (15) days after its publication
11 in a newspaper of general circulation.
