AN ACT CONVERTING THE CALBAYOG CITY DISTRICT HOSPITAL  
AS AN EXTENSION OF THE EASTERN VISAYAS REGIONAL  
MEDICAL CENTER IN TACLOBAN CITY AND APPROPRIATING  
FUNDS THEREFOR AND FOR OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Calbayog City District Hospital located in Calbayog  
2 City, Province of Samar shall be converted as an extension hospital of the  
3 Eastern Visayas Regional Medical Center located in Tacloban City to be  
4 known as Calbayog City Regional Extension Hospital.

5           SEC. 2. All assets, movable and immovable, and records of the  
6 Calbayog City District Hospital, as well as its liabilities or obligations, are  
7 hereby transferred to the Eastern Visayas Regional Medical Center: *Provided,*  
8 That the positions, rights and security of tenure of medical and non-medical  
9 personnel shall not be impaired.

1           SEC. 3. The Department of Health, in consultation and coordination  
2 with the Eastern Visayas Regional Medical Center, shall promulgate the  
3 necessary rules and regulations for the effective implementation of this Act.

4           SEC. 4. The Secretary of Health shall immediately include in the  
5 Department's programs the operationalization of the Calbayog City District  
6 Hospital as an extension of the Eastern Visayas Regional Medical Center, the  
7 funding of which shall be included in the annual General Appropriations Act.

8           The LGU concerned shall continue to provide funding for the Calbayog  
9 City District Hospital until such time that the same is integrated as an extension  
10 hospital of the Eastern Visayas Regional Medical Center and its funding  
11 included in the annual General Appropriations Act.

12           SEC. 5. This Act shall take effect upon its approval.
