AN ACT CONVERTING THE SIARGAO DISTRICT HOSPITAL AT DAPA,
SIARGAO ISLAND, SURIGAO DEL NORTE INTO AN ANNEX OF
THE CARAGA REGIONAL HOSPITAL IN SURIGAO CITY AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines
in Congress assembled:*

SECTION 1. *Conversion into an Annex Hospital.* – The Siargao District Hospital at Dapa, Siargao Island, Surigao del Norte is hereby converted into an annex of the Caraga Regional Hospital in Surigao City to be known as the Caraga Regional Hospital Annex.

SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets, liabilities and records of the Siargao District Hospital are hereby transferred to and incorporated to the Caraga Regional Hospital Annex.

SEC. 3. *Appropriations.* – The Secretary of the Department of Health shall immediately include in the Department's programs the operationalization of the Caraga Regional Hospital Annex, the funding of which shall be included in the annual General Appropriations Act.

The LGU concerned shall continue to provide funding for the Siargao District Hospital until such time that the same is integrated as an annex of the Caraga Regional Hospital and its funding included in the annual General Appropriations Act.

SEC. 4. *Implementation.* – The Secretary of Health shall issue orders, rules and circulars as may be necessary to carry out the implementation of this Act.

SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after its publication in the *Official Gazette*.
