AN ACT CONVERTING THE PROVINCIAL ROAD CONNECTING THE  
MUNICIPALITIES OF SENATOR NINOY AQUINO, LEBAK AND  
KALAMANSIG, PROVINCE OF SULTAN KUDARAT INTO A  
NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The provincial road connecting the municipalities of  
2           Senator Ninoy Aquino, Lebak and Kalamansig, Province of Sultan Kudarat is  
3           hereby converted into a national road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5           Highways shall issue the necessary rules, orders and circulars to implement the  
6           provision of this Act.

7           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8           in a newspaper of general circulation.
