AN ACT CONVERTING THE PROVINCIAL ROAD FROM THE MUNICIPALITY OF BONIFACIO TO THE MUNICIPALITY OF DON VICTORIANO, PROVINCE OF MISAMIS OCCIDENTAL INTO A NATIONAL ROAD

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

 - SEC. 2. The Secretary of the Department of Public Works and Highways shall issue the necessary rules, orders and circulars to implement the provision of this Act.
- SEC. 3. This Act shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
