





AN ACT CONVERTING THE PROVINCIAL ROAD FROM THE MUNICIPALITY OF BONIFACIO TO THE MUNICIPALITY OF DON VICTORIANO, PROVINCE OF MISAMIS OCCIDENTAL INTO A NATIONAL ROAD

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The provincial road from the Municipality of Bonifacio to
2 the Municipality of Don Victoriano, Province of Misamis Occidental is hereby
3 converted into a national road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in a newspaper of general circulation.
