





AN ACT CONVERTING THE SAN JOSE CITY – RIZAL PROVINCIAL ROAD VIA PALESTINA – PINILI – PORAIS – VILLA JOSON – STA. MONICA – PORTAL, PROVINCE OF NUEVA ECIJA INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The San Jose City – Rizal Provincial Road via Palestina –  
2 Pinili – Porais – Villa Joson – Sta. Monica – Portal, Province of Nueva Ecija is  
3 hereby converted into a national road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5 Highways shall issue the necessary rules, orders and circulars to implement  
6 the provision of this Act.

7           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8 in a newspaper of general circulation.
