AN ACT CONVERTING THE DEMOLOC -- LITTLE BAGUIO -- ALABEL
ROAD LINKING THE MUNICIPALITY OF MALITA, PROVINCE
OF DAVAO DEL SUR AND THE MUNICIPALITY OF ALABEL,
PROVINCE OF SARANGANI INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Demoloc – Little Baguio – Alabel Road linking the
2 Municipality of Malita, Province of Davao del Sur and the Municipality of
3 Alabel, Province of Sarangani is hereby converted into a national road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in a newspaper of general circulation.
