



AN ACT CONVERTING THE SILAY – LANTAWAN ROAD IN THE  
CITY OF SILAY, PROVINCE OF NEGROS OCCIDENTAL INTO A  
NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Silay – Lantawan Road in the City of Silay, Province  
2 of Negros Occidental is hereby converted into a national road.

3           SEC. 2. The Secretary of the Department of Public Works and  
4 Highways shall issue the necessary rules, orders and circulars to implement the  
5 provision of this Act.

6           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
7 in a newspaper of general circulation.
