AN ACT CONVERTING THE BONGABONG – SAGANA – ROXAS –
SAN AQUILINO PROVINCIAL ROAD, PROVINCE OF ORIENTAL
MINDORO INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Bongabong – Sagana – Roxas – San Aquilino
2 Provincial Road, Province of Oriental Mindoro is hereby converted into a
3 national road.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in a newspaper of general circulation.
