AN ACT CONVERTING THE ILOILO CITY – LEGANES – DUMANGAS COASTAL ROAD, PROVINCE OF ILOILO INTO A NATIONAL ROAD

SECTION 1. The Iloilo City – Leganes – Dumangas Coastal Road

 City, Province of Iloilo is hereby converted into a national road.
