



### AN ACT CONVERTING THE ILOILO CITY – LEGANES – DUMANGAS COASTAL ROAD, PROVINCE OF ILOILO INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Iloilo City – Leganes – Dumangas Coastal Road  
2 which traverses along coastal communities in Dumangas, Leganes and Iloilo  
3 City, Province of Iloilo is hereby converted into a national road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5 Highways shall issue the necessary rules, orders and circulars to implement the  
6 provision of this Act.

7           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8 in a newspaper of general circulation.
