



BY REPRESENTATIVE ABAYA, PER COMMITTEE REPORT NO. 1019

AN ACT CONVERTING A PORTION OF THE KAWIT – NOVELETA DIVERSION ROAD, PROVINCE OF CAVITE INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. A portion of the Kawit – Noveleta Diversion Road
2 servicing the Cavite Economic Zone from kilometer 23+400 to kilometer
3 27+225 with a total length of 3.825 kilometers in the Province of Cavite is
4 hereby converted into a national road.

5 SEC. 2. The Secretary of the Department of Public Works and
6 Highways shall issue the necessary rules, orders and circulars to implement the
7 provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in a newspaper of general circulation.
