Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. A portion of the Kawit Noveleta Diversion Road
- 2 servicing the Cavite Economic Zone from kilometer 23+400 to kilometer
- 3 27+225 with a total length of 3.825 kilometers in the Province of Cavite is
- 4 hereby converted into a national road.
- 5 SEC. 2. The Secretary of the Department of Public Works and
- 6 Highways shall issue the necessary rules, orders and circulars to implement the
- 7 provision of this Act.
- 8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
- 9 in a newspaper of general circulation.
