The Committees on Education, Arts and Culture and on Finance to which was referred House Bill No. 5642, introduced by Representatives Jalosjos-Carreon, Jalosjos, Villar, Cua (J.), Javier, Remulla, Chatto, Padilla, Madrona, Nicolas, Del Mar, Amatong, Aquino, Mitra, De Guzman, Garay and Angping, entitled:

"AN ACT

CONVERTING THE JOSE RIZAL MEMORIAL STATE COLLEGE (JRMSC) IN THE CITY OF DAPITAN, PROVINCE OF ZAMBOANGA DEL NORTE INTO A STATE UNIVERSITY TO BE KNOWN AS THE JOSE RIZAL MEMORIAL STATE UNIVERSITY (JRMSU), INTEGRATING THEREWITH THE KATIPUNAN NATIONAL AGRICULTURAL SCHOOL (KNAS) IN THE MUNICIPALITY OF KATIPUNAN AND THE ZAMBOANGA DEL NORTE AGRICULTURAL COLLEGE (ZNAC) IN THE MUNICIPALITY OF TAMPILISAN, BOTH MUNCIPALITIES LOCATED IN THE PROVINCE OF ZAMBOANGA DEL NORTE AND APPROPRIATING FUNDS THEREFOR"

- 1. On Page 2, Line 24, After the words "Region IX" insert: "PROVIDED, THAT NO DEGREE PROGRAM SHALL BE OFFERED WITHOUT THE APPROVAL OF THE COMMISSION ON HIGHER EDUCATION BEFORE THE SAME SHALL BE APPROVED BY ITS BOARD."
- 2. On Page 11, Delete Lines 1-4, and replace with: "THE PRESIDENT OF THE UNIVERSITY SHALL BE ASSISTED BY THE VICE-PRESIDENT/S, WHO SHALL BE APPOINTED BY THE BOARD UPON RECOMMENDATION OF THE PRESIDENT."
- On Page 14, Line 11, Insert a new section:
 "SECTION 22. CHED MONITORING AND EVALUATION. THE COMMISSION ON HIGHER EDUCATION SHALL CONDUCT REGULAR MONITORING AND EVALUATION TO DETERMINE CONTINUING

COMPLIANCE WITH THE REQUIREMENTS ON UNIVERSITY STATUS. IN THE EVENT THAT THE COMMISSION FINDS THAT THE UNIVERSITY DOES NOT MAINTAIN COMPLIANCE THEREOF, IT SHALL SUBMIT THE APPROPRIATE RECOMMENDATION FOR THE REVOCATION OF THE UNIVERSITY STATUS TO THE SENATE COMMITTEE ON EDUCATION, ARTS, AND CULTURE, AND THE HOUSE COMMITTEE ON HIGHER AND TECHNICAL EDUCATION."

4. Renumber the subsequent sections accordingly.

- AN ACT CONVERTING THE JOSE RIZAL MEMORIAL STATE COLLEGE (JRMSC) IN THE CITY OF DAPITAN, PROVINCE OF ZAMBOANGA DEL NORTE INTO A STATE UNIVERSITY TO BE KNOWN AS THE JOSE RIZAL MEMORIAL STATE UNIVERSITY (JRMSU), INTEGRATING THEREWITH THE KATIPUNAN NATIONAL AGRICULTURAL SCHOOL (KNAS) IN THE MUNICIPALITY OF KATIPUNAN AND THE ZAMBOANGA DEL NORTE AGRICULTURAL COLLEGE (ZNAC) IN THE MUNICIPALITY OF TAMPILISAN, BOTH MUNICIPALITIES LOCATED IN THE PROVINCE OF ZAMBOANGA DEL NORTE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled;

1 SECTION 1. Conversion/Integration. - The Jose Rizal Memorial State 2 College (JRMSC) in the City of Dapitan, Province of Zamboanga del Norte is 3 hereby converted into a state university to be known as the Jose Rizal 4 Memorial State University (JRMSU), hereinafter referred to as the University, 5 integrating therewith the Katipunan National Agricultural School (KNAS) in the Municipality of Katipunan and the Zamboanga del Norte Agricultural
 College (ZNAC) in the Municipality of Tampilisan, both municipalities located
 in the Province of Zamboanga del Norte. The main campus of the University
 shall be in the City of Dapitan.

5 SEC, 2. General Mandate. - The University shall primarily provide advanced education, higher technological, professional instruction and training 6 7 in arts and sciences, philosophy, literature, mass communication, teacher 8 education, agriculture and forestry, fishery, engineering and architecture, 9 maritime education, industrial and information technology, hotel and restaurant management, tourism, medicine, nursing and allied health sciences, 10 11 criminology, geology, public administration, business and accountancy, law, nontraditional courses and other relevant fields of study. It shall also 12 undertake research and extension services, and provide progressive leadership 13 in its areas of specialization. 14

– The University shall offer 15 SEC, 3. Curricular Offerings. undergraduate and graduate courses in arts and sciences, philosophy, literature, 16 mass communication, teacher education, agriculture and forestry, fishery, 17 engineering and architecture, maritime education, industrial and information 18 technology, hotel and restaurant management, tourism, medicine, nursing and 19, allied health sciences, criminology, geology, public administration, business 20 and accountancy, law, nontraditional courses and other degrees/courses within 21 its areas of specialization and according to its capabilities, as the Board of 22Regents may deem necessary to carry out its objectives, particularly to meet 23 the needs of the Province of Zamboanga del Norte and Region IX. 24

The existing high schools shall be transferred to the jurisdiction and supervision of the Department of Education (DepEd): *Provided*, That the high schools shall be allowed to remain and operate within the campus of the University until the students, who are currently enrolled, shall have completed

their high school education: Provided, further, That the University may 1 operate a reasonably-sized laboratory school, if it has a College of Education. 2 SEC. 4. Administration. - The University shall have the general powers 3 of a corporation set forth in Batas Pambansa Blg. 68, as amended, otherwise 4 5 known as "The Corporation Code of the Philippines". The administration of the University and the exercise of its corporate powers shall be vested б 7 exclusively in the Board of Regents and the President of the University. 8 SEC. 5, The Governing Board. - The governing board of the 9 University shall be the Board of Regents, hereinafter referred to as the Board, 10 which shall be composed of the following: 11 (a) The Chairperson of the Commission on Higher Education (CHED), Chairperson; 12 (b) The President of the University, Vice Chairperson; 13 14 (c) The Chairperson of the Committee on Education, Arts and Culture of the Senate, member; 15 (d) The Chairperson of the Committee on Higher and Technical 16 17 Education of the House of Representatives, member; 18 (e) The Regional Director of the National Economic and Development 19 Authority (NEDA), member; 20 (f) The Regional Director of the Department of Science and Technology (DOST), member; 21 22(g) The President of the federation of faculty associations of the 23 University, member; (h) The President of the federation of student councils of the 24 25 University, member; (i) The President of the federation of alumni associations of the 26 University, member; and 27

1 (j) Two (2) prominent citizens from the private sector who have 2 distinguished themselves in their profession or fields of specialization of the 3 University, members. 4 The Board shall appoint the two (2) prominent citizens from among a 5 list of at least five (5) qualified persons in the Province of Zamboanga del Norte, as recommended by the search committee constituted by the University 6 7 President, in consultation with the Chairperson of the CHED and the other members of the Board, based on the normal standards and qualifications for 8 9 the position. 10 The term of office of the President of the federation of faculty associations, the President of the federation of student councils and the 11 President of the federation of alumni associations shall be coterminous with 12 13 their terms of office, as set forth in their respective constitutions and bylaws. 14 The two (2) prominent citizens shall serve for a term of two (2) years 15 from the date of appointment. SEC. 6. Promulgation and Implementation of Policies. - The Board 16 17 shall promulgate and implement policies in accordance with the declared State 18 policies on education and other pertinent provisions of the Philippine 19 Constitution on education, agriculture, science and technology, as well as the 20policies, standards and thrusts of the CHED under Republic Act No. 7722, 21 otherwise known as the "Higher Education Act of 1994". SEC. 7. Powers and Duties of the Board of Regents. -- The Board shall 22 have the following specific powers and duties, in addition to its general powers 23 of administration and the exercise of all the powers granted to the board of 24 25 directors of a corporation under existing laws: (a) To promulgate rules and regulations not contrary to law as may be 26 27 necessary to carry out the purposes and functions of the University;

(b) To receive and appropriate all sums as may be provided for the support of the University in the manner it may determine in its discretion, in order to carry out the purposes and functions of the University;

4 (c) To import duty-free economic, technical and cultural books and/or 5 publications, upon certification by the CHED that such imported books and/or 6 publications are for economic, technical, vocational, scientific, philosophical, 7 historical or cultural purposes, in accordance with the provisions of the Tariff 8 and Customs Code of the Philippines, as amended;

9 (d) To receive in trust legacies, gifts and donations of real and personal 10 properties of all kinds and to administer and dispose of the same when 11' necessary for the benefit of the University, subject to the limitations, directions 12 and instructions of the donor, if any.

13 Such donations shall be exempt from the donor's tax and the same shall 14 be considered as allowable deductions from the gross income in the 15 computation of the income tax of the donor, in accordance with the provisions 16 of the National Internal Revenue Code (NIRC) of 1997, as amended: 17 *Provided*, That such donations shall not be disposed of, transferred or sold;

(e) To fix the tuition fees and other necessary school charges such as,
but not limited to, matriculation fees, graduation fees and laboratory fees, as
the Board may deem proper to impose, after due consultations with the
involved sectors.

Such fees and charges, including government subsidies and other income generated by the University, shall constitute special trust funds and shall be deposited in any authorized government depository bank, and all interests that shall accrue therefrom shall form part of the same funds for the use of the University.

Any provision of existing laws, rules and regulations to the contrarynotwithstanding, any income generated by the University from tuition fees and

other charges, as well as from the operation of auxiliary services and land grants, shall be retained by the University, and may be disbursed by the Board for instruction, research, extension or other programs/projects of the University: *Provided*, That all fiduciary fees shall be disbursed for the specific purposes for which these are collected.

6 If, for reasons beyond its control, the University shall not be able to 7 pursue any project for which the funds have been appropriated and allocated 8 under its approved program of expenditures, the Board may authorize the use 9 of said funds for any reasonable purpose which, in its discretion, may be 10 necessary and urgent for the attainment of the objectives and goals of the 11 University;

12 (f) To adopt and implement a socialized scheme of tuition and other13 school fees for greater access to poor but deserving students;

(g) To authorize the construction or repair of its buildings, machinery,
equipment and other facilities, and the purchase and acquisition of real
property, including necessary supplies, materials and equipment;

17 (h) To appoint upon recommendation of the President of the
18 University, Vice Presidents, deans, directors, heads of campuses, faculty
19 members, and other officials and employees of the University;

(i) To fix and adjust salaries of faculty members and administrative 20 officials and employees, subject to the provisions of the Revised Compensation 21 and Position Classification System and other pertinent budget and 22 compensation laws governing hours of service and such other duties and 23 conditions as it may deem proper; to grant them, at its discretion, leaves of 24 absence under such regulations as it may promulgate, any provision of existing 25 law to the contrary notwithstanding; and to remove them for cause in 26 accordance with the requirements of due process of law; 27

1 (j) To approve the curricula, instructional programs and rules of 2 discipline drawn by the Administrative and Academic Councils herein 3 provided;

(k) To set policies on admission and graduation of students;

4

5 (1) To award honorary degrees upon persons in recognition of their 6 outstanding contribution in the fields of education, public service, arts, science 7 and technology, agriculture or in any field of specialization within the 8 academic competence of the University; and to authorize the awarding of 9 certificates of completion of nondegree and nontraditional courses;

10 (m) To establish and absorb nonchartered tertiary institutions within 11 the Province of Zamboanga del Norte as branches and centers in coordination 12 with the CHED and in consultation with the Department of Budget and 13 Management (DBM), and to offer therein programs or courses, to promote and 14 carry out equal access to educational opportunities as mandated by the 15 Constitution;

16 (n) To establish research and extension centers of the University where
17 such will promote the development of the latter;

(o) To establish professorial chairs in the University and to provide
fellowships for qualified faculty members and scholarships to deserving
students;

(p) To delegate any of its powers and duties provided for hereinabove
to the President and/or other officials of the University as it may deem
appropriate, so as to expedite the administration of the affairs of the
University;

(q) To authorize an external management audit of the University, to be
financed by the CHED, subject to the rules and regulations of the Commission
on Audit (COA); and to institute reforms, including academic and structural
changes, on the basis of the audit results and recommendations;

1 (r) To collaborate with other governing boards of the state colleges and 2 universities within the Province of Zamboanga del Norte or Region IX, under 3 the supervision of the CHED and in consultation with the DBM, and work 4 towards the restructuring of the University to become more efficient, relevant, 5 productive and competitive; 6 (s) To enter into joint ventures with business and industry for the 7 profitable development and management of the economic assets of the University, the proceeds from which shall be used for the development and 8 9 strengthening of the University; 10 (t) To develop consortia and other economic forms of linkages with local government units (LGUs), institutions and agencies, both public and 11 12 private, local and foreign, in the furtherance of the purposes and objectives of 13 the University; 14 (u) To develop academic arrangements for institutional capability 15 building with appropriate institutions and agencies, public and private, local and foreign, and to appoint experts/specialists as consultants, part-time or 16 visiting or exchange professors, scholars or researchers, as the case may be; 17 (v) To set up the adoption of modern and innovative modes of 18 transmitting knowledge such as the use of information technology, the dual 19 learning system, open learning or distance education and community 20 laboratory for the promotion of greater access to education; 21 (w) To establish policy guidelines and procedures for participative 22 decision-making and transparency within the University; 23 (x) To privatize, where most advantageous to the University, the 24 25 management of nonacademic services such as health, food, building or grounds or property maintenance and such other similar activities; and 26 (y) To extend the term of the President of the University beyond the 27 28 age of retirement, but not beyond the age of seventy (70), whose performance

has been unanimously rated by the Board as outstanding, based on the
 guidelines, qualifications and/or standards set by the Board, after unanimous
 recommendation by the search committee.

4 SEC. 8. *Meetings of the Board.* – The Board shall regularly convene at 5 least once every quarter. However, the Chairperson of the Board may, upon 6 three (3) days' prior written notice, call a maximum of two (2) special 7 meetings whenever necessary.

8 A quorum of the Board shall consist of majority of all its members 9 holding office at the time of the meeting: *Provided, however*, That the 10 Chairperson of the Board or the President of the University is among those 11 present in the meeting.

In the absence of the Chairperson of the CHED, a Commissioner of the 12 CHED, duly designated by him/her, shall represent him/her in the meeting with 13 all the rights and responsibilities of a regular member: Provided, however, 14 That during this meeting, the President of the University as Vice Chairperson 15 shall be the Presiding Officer: Provided, further, That this proviso 16 17 notwithstanding, the Chairperson of the CHED is hereby authorized to designate a CHED Commissioner as the regular Chair of the Board, in which 18 case said CHED Commissioner shall act as the Presiding Officer. 19

In case the Chairpersons of the Congressional Committees on Education shall not be able to attend the Board meeting, they may duly designate their respective representatives to attend the said meeting, who shall have the same rights and responsibilities as a regular member of the Board.

The members of the Board shall not receive any salary but shall be entitled to reimbursements for actual and necessary expenses incurred, either in their attendance to meetings of the Board or in connection with other official business authorized by resolution of the Board, subject to existing laws and regulations.

1 SEC. 9. The University President. - The University shall be headed by 2 a President, who shall render full-time service. He/She shall be appointed by 3 the Board, subject to the guidelines, qualifications and/or standards set by the Board, upon recommendation of a duly constituted search committee. He/She 4 5 shall have a term of four (4) years and shall be eligible for reappointment for 6 another term: Provided, That in order to effect a smooth transition to a state 7 university, the incumbent President of the JRMSC, if qualified, shall serve as 8 the first President of the University. 9 Within six (6) months before the expiration of the term of office of the incumbent President of the University, the Board shall constitute the Search 10 Committee for the Presidency (SCP). 11 12 In case of vacancy in the Office of the President by reason of death, compulsory retirement, resignation, removal for cause or incapacity of the 13 President to perform the functions of his/her office, the Board shall designate 14 an Officer-in-Charge of the University within six (6) months from the date of 15 vacancy, pending the appointment of a new President. 16 In case of vacancy in the Office of the President as mentioned in the 17 immediately preceding paragraph, his/her successor or the Officer-in-Charge 18 shall serve only the unexpired portion of the term. 19 The powers and duties of the President of the University, in addition to 20 those specifically provided in this Act, shall be those usually pertaining to the 21 Office of the President of similar universities, and those delegated by the 22 Board. 23 The salary of the President of the University shall be in accordance with 24 the Revised Compensation and Position Classification System and shall be 25 comparable to that being received by the Presidents of similar educational 26

27 institutions.

The President of the University shall be assisted by a Vice President for
 Academic Affairs, a Vice President for Administration and a Vice President
 for Research, Extension and Development, who shall be appointed by the
 Board upon recommendation of the President.

5 SEC. 10. *Heads of University Campuses.* – Campus Directors shall 6 head the University campuses and they shall render full-time service. They 7 shall be appointed by the Board upon recommendation of the search committee 8 and the University President, subject to the guidelines, qualifications and/or 9 standards set by the Board: *Provided*, That the incumbent college 10 administrators of the extension campuses shall serve as Campus Directors of 11 their respective campuses.

12 SEC. 11. *The Administrative Council.* – There shall be an 13 Administrative Council consisting of the President of the University as 14 Chairperson, Vice Presidents, deans, directors and other officials of equal rank 15 as members, whose duty is to review and recommend to the Board policies 16 governing the administration, management and development planning of the 17 University.

18 SEC. 12. The Academic Council. – There shall be an Academic Council 19 to be composed of the President of the University, who shall act as 20 Chairperson, and all academic staff with the rank of at least an assistant 21 professor, as members.

The Academic Council shall have the power to review and recommend the curricular offerings and rules of discipline of the University, subject to the approval of the Board. It shall fix the requirements for the admission of students, as well as for their graduation and conferment of degrees, subject to review and/or approval by the Board through the President of the University. It shall have the disciplinary power over students of the University and shall

formulate academic policies and rules and regulations on discipline, subject to
 the approval of the Board.

3 SEC. 13. The Secretary of the University. - The Board shall appoint a 4 secretary, who shall serve as such for both the Board and the University and 5 shall keep all records and proceedings of the Board. He/She shall serve upon 6 each member of the Board the appropriate notice of the Board meetings.

7 SEC. 14. The Treasurer of the University. - The Treasurer of the
8 Philippines shall be the ex officio treasurer of the University.

9 SEC. 15. The Faculty. – No political beliefs, gender preference, 10 cultural or community affiliation or ethnic origin, and religious opinion or 11 affiliation shall be a matter of inquiry in the appointment of faculty members of 12 the University: *Provided*, That said appointment shall be subject to the 13 guidelines, qualifications and/or standards set by the Board: *Provided*, further, 14 That no member of the faculty shall teach for or against any particular church 15 or religious sect.

SEC. 16. Scholarship Program/Admission. - The University shall
provide a scholarship program and other affirmative action programs to assist
poor but deserving students who qualify for admission to the University.

No student shall be denied admission to the University by reason of sex,
religion, cultural or community affiliation or ethnic origin.

SEC. 17. Academic Freedom and Institutional Autonomy. - The
 University shall enjoy academic freedom and institutional autonomy, pursuant
 to paragraph 2, Section 5 of Article XIV of the Constitution of the Republic of
 the Philippines.

SEC. 18. Authority to Loan or Transfer Apparatus/Equipment/Supplies
 and Detail of Personnel. - The heads of the bureaus and offices of the national
 government are hereby authorized to loan or transfer, upon the request of the
 President of the University, such apparatus, equipment or supplies as may be

needed by the University, and to detail employees for duty therein when, in the
 judgment of the head of the bureau or office, such apparatus, equipment,
 supplies or services of such employees can be spared without serious detriment
 to the public service.

5 The employees so detailed shall perform such duties as required of them 6 by the President of the University, and the time so employed shall be counted 7 as part of their regular services.

8 SEC. 19. Assets, Liabilities and Personnel. – All assets, real and 9 personal, personnel and records of the Jose Rizal Memorial State College, as 10 well as liabilities or obligations, are hereby transferred to the University. The 11 positions, rights and security of tenure of faculty members and personnel 12 therein employed under existing laws prior to the conversion into a University 13 shall be respected.

All parcels of land belonging to the government occupied by the Jose Rizal Memorial State College, the Katipunan National Agricultural School and the Zamboanga del Norte Agricultural College are hereby declared to be property of the University, and shall be titled under that name: *Provided*, That should the University cease to exist or be abolished or should such parcels of land aforementioned be no longer needed by the University, the same shall revert to the LGUs concerned.

SEC, 20. Appropriations. - The amount necessary to carry out the 21 provisions of this Act shall be charged against the current year's appropriations 22 of the Jose Rizal Memorial State College, the Katipunan National Agricultural 23 School and the Zamboanga del Norte Agricultural College, except the sums 24 needed to continue the operations of the existing high school/s. Thereafter, 25 such sums as may be necessary for the continued operation and maintenance of 26 the Jose Rizal Memorial State University shall be included in the annual 27 General Appropriations Act. 28

I SEC. 21. Development Plan, Management Audit, 2 Organizational/Administrative/Academic Structure. - Within the period of one 3 hundred twenty (120) days after the approval of this Act, the University shall 4 accomplish the following: 5 (a) Submit a five (5)-year development plan, including its 6 corresponding program budget to the CHED, for corresponding 7 recommendation to the DBM; 8 (b) Undergo a management audit in cooperation with the CHED; and 9 (c) Accordingly set up its organizational, administrative as well as 10 academic structure including the appointment of the key officials of the University. 11 SEC. 22. Filing of Report. - On or before the fiftcenth (15th) day of the 12 second (2nd) month after the opening of the regular classes each year, the 13 Board shall file with the Office of the President of the Philippines, through the 14 15, Chairperson of the CHED, and with both Houses of Congress a detailed report on the progress, conditions and needs of the University. 16 SEC. 23. Suppletory Application. - The provisions of Republic Act No. 17 8292, otherwise known as the "Higher Education Modernization Act of 1997", 18 shall be an integral part of this Act and shall serve as part of the Governing 19 20 Charter of the University. SEC. 24. Parity Clause. - All other powers, functions and privileges, 21 responsibilities and limitations to state universities and/or their officials under 22 existing laws shall be deemed granted to or imposed upon the University 23 and/or its officials, whenever appropriate. 24 SEC. 25. Implementing Rules and Regulations. - The Board, in 25 consultation with the CHED, shall formulate the guidelines to fully implement 26 27 the provisions of this Act.

1	SEC. 26. Separability Clause If, for any reason, any part or provision
2	of this Act is declared invalid or unconstitutional, the remaining parts or
3	provisions not affected thereby shall remain in full force and effect.
4	SEC. 27. Repealing Clause All laws, presidential decrees, executive
5	orders, rules and regulations contrary to or inconsistent with the provisions of
6	this Act are hereby repealed or modified accordingly.
7	SEC. 28. Effectivity This Act shall take effect fifteen (15) days after
8	its publication in two (2) newspapers of general circulation.
