have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved without amendment.



BY REPRESENTATIVE BELMONTE, PER COMMITTEE REPORT NO. 495

AN ACT SEPARATING THE CITY OF ILIGAN FROM THE FIRST
LEGISLATIVE DISTRICT OF THE PROVINCE OF LANA DEL
NORTE TO CONSTITUTE THE LONE LEGISLATIVE DISTRICT
OF THE CITY OF ILIGAN

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Lone Legislative District.* – The City of Iligan is hereby
2 separated from the First Legislative District of the Province of Lanao del Norte
3 to constitute the Lone Legislative District of the City of Iligan, which shall
4 commence in the next national election after the effectivity of this Act.

5 SEC. 2. *Incumbent Representative.* – The incumbent Representative of
6 the First Legislative District of the Province of Lanao del Norte shall continue
7 to represent the said district until the new Representative of the Lone
8 Legislative District of the City of Iligan shall have been elected and qualified.

9 SEC. 3. *Rules and Regulations.* – The Commission on Elections shall
10 issue the necessary rules and regulations to implement this Act.

11 SEC. 4. *Repealing Clause.* – All laws, rules and regulations
12 inconsistent with this Act are hereby repealed, amended or modified
13 accordingly.

14 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
15 its publication in at least two (2) newspapers of general circulation.
