## **HOUSE OF REPRESENTATIVES**

BY REPRESENTATIVES CABILAO, DE GUZMAN AND LAGMAN, PER COMMITTEE REPORT NO. 449

AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY BATERIA, MUNICIPALITY OF OLUTANGA, PROVINCE OF ZAMBOANGA SIBUGAY TO BE KNOWN AS PANTALEON CUDIERA MEMORIAL NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. Establishment of a National High School. There is hereby established, under the supervision of the Department of Education, a national high school in Barangay Bateria, Municipality of Olutanga, Province of Zamboanga Sibugay to be known as Pantaleon Cudiera Memorial National High School.
  - SEC. 2. Appropriations. The Secretary of Education shall immediately include in the Department's program the operationalization of Pantaleon Cudiera Memorial National High School, the funding of which shall be included in the annual General Appropriations Act.
- SEC. 3. Implementation. The Secretary of Education shall issue such rules and regulations as may be necessary to carry out the purpose of this Act.
  - SEC. 4. Effectivity. This Act shall take effect fifteen (15) days after its publication in the Official Gazette.
