
The Committees on Education, Arts and Culture and on Finance to which





AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY  
BATERIA, MUNICIPALITY OF OLUTANGA, PROVINCE OF  
ZAMBOANGA SIBUGAY TO BE KNOWN AS PANTALEON  
CUDIERA MEMORIAL NATIONAL HIGH SCHOOL AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1       SECTION 1. *Establishment of a National High School.* – There is  
2 hereby established, under the supervision of the Department of Education, a  
3 national high school in Barangay Bateria, Municipality of Olutanga, Province  
4 of Zamboanga Sibugay to be known as Pantaleon Cudiera Memorial National  
5 High School.

6       SEC. 2. *Appropriations.* – The Secretary of Education shall  
7 immediately include in the Department's program the operationalization of  
8 Pantaleon Cudiera Memorial National High School, the funding of which shall  
9 be included in the annual General Appropriations Act.

10       SEC. 3. *Implementation.* – The Secretary of Education shall issue such  
11 rules and regulations as may be necessary to carry out the purpose of this Act.

12       SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after  
13 its publication in the *Official Gazette*.
