



AN ACT DECLARING JUNE 23 OF EVERY YEAR AS A SPECIAL  
NONWORKING HOLIDAY IN THE CITY OF TANDAG,  
PROVINCE OF SURIGAO DEL SUR TO BE KNOWN AS THE  
"CHARTER DAY OF TANDAG CITY"

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. June 23 of every year is hereby declared as a special  
2 nonworking holiday in the City of Tandag, Province of Surigao del Sur to be  
3 known as the "Charter Day of Tandag City".

4           SEC. 2. This Act shall take effect fifteen (15) days after its publication  
5 in the *Official Gazette* or in a newspaper of general circulation.
