Mr. President:

The Committees on Education, Arts and Culture and on Finance to which was referred House Bill No. 3770, introduced by Reps. Chong, De Guzman, and Cua (J.), entitled:

"AN ACT

ESTABLISHING AN ARTS AND CULTURE HIGH SCHOOL IN BARANGAY TAMARINDO, MUNICIPALITY OF ALMERIA, PROVINCE OF BILIRAN TO BE KNOWN AS WESTERN BILIRAN HIGH SCHOOL FOR THE ARTS AND CULTURE AND APPROPRIATING FUNDS THEREFOR"

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1. On lines 1 and 3 of the only page of the bill, delete the phrase "an arts and culture," and replace with the phrase "a national special"; and
- 2. On the title of the bill, delete the phrase "AN ARTS AND CULTURE" and replace with the phrase "A NATIONAL SPECIAL", so that the amended title shall now read:

ESTABLISHING A NATIONAL SPECIAL HIGH SCHOOL IN BARANGAY TAMARINDO, MUNICIPALITY OF ALMERIA, PROVINCE OF BILIRAN TO BE KNOWN AS WESTERN BILIRAN HIGH SCHOOL FOR THE ARTS AND CULTURE AND APPROPRIATING FUNDS THEREFOR"

AN ACT ESTABLISHING AN ARTS AND CULTURE HIGH SCHOOL IN BARANGAY TAMARINDO, MUNICIPALITY OF ALMERIA, PROVINCE OF BILIRAN TO BE KNOWN AS WESTERN BILIRAN HIGH SCHOOL FOR THE ARTS AND CULTURE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Establishment of an Arts and Culture High School				
2	There is hereby established, under the supervision of the Department of				
3	Education, an arts and culture high school in Barangay Tamarindo,				
4	Municipality of Almeria, Province of Biliran to be known as Western Biliran				
5	High School for the Arts and Culture.				
6	SEC. 2. Appropriations The Secretary of Education shall				
7	immediately include in the Department's program the operationalization of the				
8	Western Biliran High School for the Arts and Culture, the funding of which				
9	shall be included in the annual General Appropriations Act.				
10	SEC. 3. Implementation The Secretary of Education shall issue rules				
11	and regulations that may be necessary to carry out the purpose of this Act.				
12	SEC. 4. Effectivity This Act shall take effect fifteen (15) days after				
13	its publication in the Official Gazette.
