

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:


- (1) On page 1, line 13, replace the word "Tagoloan" with the word "KAPATAGAN";

AN ACT PROVIDING FOR THE REAPPORTIONMENT OF  
LEGISLATIVE DISTRICTS IN THE PROVINCE OF LANA O DEL  
NORTE

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Legislative Districts.* – The Province of Lanao del Norte,  
2           which shall have two (2) legislative districts consisting of twenty-two (22)  
3           municipalities to commence in the next elections after the effectivity of this  
4           Act, is hereby reapportioned as follows:

- 5           FIRST DISTRICT
- 6           (1) Baroy
- 7           (2) Tubod
- 8           (3) Kolambugan
- 9           (4) Maigo
- 10          (5) Bacolod
- 11          (6) Kauswagan
- 12          (7) Linamon
- 13          (8) Tagoloan
- 14          (9) Baloi

- 1 (10) Matunggao
- 2 (11) Pantar
- 3 SECOND DISTRICT
- 4 (1) Pantao Ragat
- 5 (2) Poona Piagapo
- 6 (3) Munai
- 7 (4) Tangkal
- 8 (5) Magsaysay
- 9 (6) Salvador
- 10 (7) Lala
- 11 (8) Sultan Naga Dimaporo (SND)
- 12 (9) Kapatagan
- 13 (10) Sapad
- 14 (11) Nunungan

15 SEC. 2. *Incumbent Representatives.* – The incumbent representatives of  
16 the first and second legislative districts of the Province of Lanao del Norte  
17 shall continue to represent their respective legislative districts until the new  
18 representatives shall have been elected and qualified.

19 SEC. 3. *Rules and Regulations.* – The Commission on Elections shall  
20 issue the necessary rules and regulations to implement this Act.

21 SEC. 4. *Repealing Clause.* – All laws, rules and regulations  
22 inconsistent with this Act are hereby repealed, amended or modified  
23 accordingly.

24 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
25 its publication in at least two (2) newspapers of general circulation.
