<b>SECTION 2.</b> The Supreme Court shall assign the respective branch numbers for the newly created branches.		
<b>SECTION 3.</b> Accordingly, Section 14(c) of Batas Pambansa Bilang 129, otherwise known as "The Judiciary Reorganization Act of 1980," as amended, as well as other provisions that may be inconsistent herewith, is hereby deemed repealed, modified and/or further amended.
