- 1 SECTION 1. Separation and Conversion into a National High School.
- 2 The Don Enrique Lopez National High School Don Salvador Lopez Annex
- 3 in Barangay Don Salvador Lopez, City of Mati, Province of Davao Oriental is
- 4 hereby separated from the Don Enrique Lopez National High School and
- 5 converted into an independent national high school to be known as Don
- 6 Salvador Lopez National High School.
- 7 SEC. 2. Transfer of Assets and Liabilities. All personnel, assets,
- 8 liabilities and records of the Don Enrique Lopez National High School Don

1	Salvador Lopez Annex are hereby transferred to and absorbed by the Don
2	Salvador Lopez National High School.
3	SEC. 3. Appropriations The Secretary of Education shall
4	immediately include in the Department's program the operationalization of the
5	Don Salvador Lopez National High School, the initial funding of which shall
6	be charged against the current year's appropriations of the Don Enrique Lopez
7	National High School - Don Salvador Lopez Annex. Thereafter, the amount
8	necessary for the continued operation of the school shall be included in the
9	annual General Appropriations Act.
10	SEC. 4. Implementation The Secretary of Education shall issue rules
11	and regulations that may be necessary to carry out the purpose of this Act.
12	SEC. 5. Effectivity This Act shall take effect fifteen (15) days after
