The Committees on Education, Arts and Culture and on Finance to which
was referred House Bill No. 5819, introduced by Reps. Alvarez (G.), De Guzman,
Lagman and Cua (J.), entitled:


"AN ACT
SEPARATING THE CANINGAY BARANGAY HIGH SCHOOL - CANDONI EXTENSION IN THE
MUNICIPALITY OF CANDONI, PROVINCE OF NEGROS OCCIDENTAL FROM THE CANINGAY
BARANGAY HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL
TO BE KNOWN AS QUERICO G. MANZANO NATIONAL HIGH SCHOOL AND APPROPRIATING
FUNDS THEREFOR"

2. On the bill's title, between the words "Manzano" and "National" insert





AN ACT SEPARATING THE CANINGAY BARANGAY HIGH SCHOOL –
CANDONI EXTENSION IN THE MUNICIPALITY OF CANDONI,
PROVINCE OF NEGROS OCCIDENTAL FROM THE CANINGAY
BARANGAY HIGH SCHOOL, CONVERTING IT INTO AN
INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS
QUERICO G. MANZANO NATIONAL HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Separation and Conversion into a National High School.*
2 – The Canningay Barangay High School – Candoni Extension in the
3 Municipality of Candoni, Province of Negros Occidental is hereby separated
4 from the Canningay Barangay High School and converted into an independent
5 national high school to be known as Querico G. Manzano National High
6 School.

7 SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,
8 liabilities and records of the Canningay Barangay High School – Candoni
9 Extension are hereby transferred to and absorbed by the Querico G. Manzano
10 National High School.

11 SEC. 3. *Appropriations.* – The Secretary of Education shall
12 immediately include in the Department's program the operationalization of the
13 Querico G. Manzano National High School, the initial funding of which shall

1 be charged against the current year's appropriations of the Canningay Barangay
2 High School – Candoni Extension. Thereafter, the amount necessary for the
3 continued operation of the school shall be included in the annual General
4 Appropriations Act.

5 SEC. 4. *Implementation.* – The Secretary of Education shall issue such
6 rules and regulations as may be necessary to carry out the purpose of this Act.

7 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
8 its publication in the *Official Gazette*.
