AN ACT PROVIDING STIFFER PENALTIES FOR ACTS IN VIOLATION OF THE MEAT INSPECTION SYSTEM, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9296, OTHERWISE KNOWN AS "THE MEAT INSPECTION CODE OF THE PHILIPPINES"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Section 4 of Republic Act No. 9296 is hereby amended by 2 inserting between subsections 15 and 16, to be designated as subsection 16, to 3 read as follows: 4 "SEC. 4. Definition of Terms. - XXX 5 "16. HOT MEAT -THE CARCASS OR PARTS OF 6 CARCASS OF FOOD ANIMALS WHICH WERE 7 SLAUGHTERED FROM UNREGISTERED/UNACCREDITED 8 MEAT ESTABLISHMENTS AND HAVE NOT UNDERGONE THE 9 REQUIRED INSPECTION. IT ALSO INCLUDES UNDOCUMENTED, 10 ILLEGALLY SHIPPED, AND UNREGISTERED CARCASS AND 11 PARTS OF CARCASS COMING FROM OTHER COUNTRIES AND 12 THOSE THAT ARE CLASSIFIED AS HOT MEAT BY THE 13 NATIONAL MEAT INSPECTION SERVICE (NMIS)." 14 The succeeding subsections shall be renumbered accordingly. 15 SEC. 2. Section 56 of Republic Act No. 9296 is hereby amended to 16 read as follows: 17 "SEC. 56. PENALTIES AND Administrative Fines. - ANY 18 PERSON, FIRM OR CORPORATION WHO SHALL TRANSPORT. 19 SELL OR OTHERWISE DISPOSE OF CARCASSES, ORGANS OR 20 PARTS THEREOF FOR FOOD WHICH HAVE NOT PASSED 21 ANTE-MORTEM AND POST-MORTEM INSPECTION BY22 COMPETENT AUTHORITY OR WHO SHALL FALSIFY, FORGE 23 OR ALTER ANY ACCOMPANYING CERTIFICATE OR OTHER

SAID CARCASSES, ORGANS OR PARTS SHALL UPON CONVICTION, SUFFER A PENALTY OF IMPRISONMENT

AND ONE (1) DAY BUT NOT MORE THAN SIX (6) YEARS OR PAY A FINE OF NOT LESS THAN TWENTY-FIVE THOUSAND PESOS (P25,000.00) BUT NOT MORE THAN FIVE HUNDRED THOUSAND PESOS (P500,000.00), OR BOTH, AT THE DISCRETION OF THE COURT. ACCOMPLICES AND ACCESSORIES IN THE CRIME SHALL SUFFER A PENALTY OF IMPRISONMENT OF NOT LESS THAN THREE (3) MONTHS AND ONE (1) DAY BUT NOT MORE THAN THREE (3) YEARS OR PAY A FINE OF NOT LESS THAN TEN THOUSAND PESOS (P10,000.00) BUT NOT MORE THAN TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00), OR BOTH, AT THE DISCRETION OF THE COURT.

"ANY PERSON, FIRM OR CORPORATION WHO SHALL STORE, TRANSPORT, SELL OR OTHERWISE DISPOSE OF MEAT AND MEAT PRODUCTS WHICH HAVE BEEN BROUGHT TO THE COUNTRY WITHOUT AUTHORITY FROM THE NMIS AND THE BUREAU OF ANIMAL INDUSTRY SHALL SUFFER A PENALTY OF IMPRISONMENT RANGING FROM ONE (1) YEAR AND ONE (1) DAY TO TEN (10) YEARS OR PAY A FINE OF NOT LESS THAN ONE HUNDRED THOUSAND PESOS (P100,000,00) BUT NOT MORE THAN ONE MILLION PESOS (P1,000,000.00) OR MORE THAN THE VALUE OF THE ILLEGALLY IMPORTED ITEMS, OR BOTH, AT THE DISCRETION OF THE COURT. ACCOMPLICES AND ACCESSORIES OF THE CRIME SHALL SUFFER A PENALTY OF IMPRISONMENT RANGING FROM SIX (6) MONTHS AND ONE (1) DAY TO FIVE (5) YEARS OR PAY A FINE OF NOT LESS THAN FIFTY THOUSAND PESOS (P50,000.00) BUT NOT MORE THAN FIVE HUNDRED THOUSAND PESOS (P500,000,00), OR BOTH, AT THE DISCRETION OF THE COURT.

1	"MEAT AND MEAT PRODUCTS DEEMED HOT MEAT
2	SHALL BE CONFISCATED AND THE CERTIFICATE OR
3	REGISTRATION OR FRANCHISE OF THE VEHICLE OR
4	CONVEYANCE USED IN THE TRANSPORT SHALL BE
5	CANCELLED. LIVESTOCK AND POULTRY FARMS AND OTHER
6	MEAT ESTABLISHMENTS WHICH ARE THE SOURCE OF THE
7	HOT MEAT, IF FOUND GUILTY TO HAVE PARTICIPATED IN THE
8	COMMISSION OF THE CRIME, SHALL SUFFER AN ADDITIONAL
9	PENALTY OF CANCELLATION OF BUSINESS PERMIT AND
10	CLOSURE OF THE FARM OR ESTABLISHMENT.
11	"ALL OTHER VIOLATIONS OF THE PROVISIONS OF THIS
12	ACT SHALL BE PENALIZED WITH IMPRISONMENT RANGING
13	FROM TWO (2) MONTHS TO NOT MORE THAN TWO (2) YEARS
14	OR PAY A FINE OF NOT LESS THAN FIVE THOUSAND PESOS
15	(P5,000.00) BUT NOT MORE THAN FIFTY THOUSAND PESOS
16	(P50,000.00), OR BOTH, AT THE DISCRETION OF THE COURT.
17	"The Secretary, by way of regulation, shall issue a
18	schedule of administrative fines for violations of any provision
19	of this Act."
20	SEC. 3. This Act shall take effect fifteen (15) days after its publication
21	in at least two (2) national newspapers of general circulation.
