



**AN ACT CONVERTING THE UBAO - TAANG PROVINCIAL ROAD IN
THE MUNICIPALITY OF AGUINALDO, PROVINCE OF IFUGAO
INTO A NATIONAL ROAD**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Ubao - Taang Provincial Road traversing barangays
2 Ubao, Chalalo, Mongayang, Botac, Aawayan, Damag, Jacmal and Taang, all in
3 the Municipality of Aguineldo, Province of Ifugao is hereby converted into a
4 national road.

5 SEC. 2. The Secretary of the Department of Public Works and
6 Highways shall issue the necessary rules, orders and circulars to implement the
7 provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in a newspaper of general circulation.-
