MR. PRESIDENT:

The Committees on Justice and Human Rights and Finance, to which was referred H. No. 4492, introduced by Reps. Gullas, Tupas, Abaya and Tañada, entitled:

**“AN ACT
CREATING TWO (2) BRANCHES OF THE REGIONAL TRIAL COURT AND A
BRANCH OF THE MUNICIPAL TRIAL COURT IN CITIES IN THE PROVINCE
OF CEBU TO BE STATIONED AT THE CITIES OF NAGA AND CARCAR,
AMENDING FOR THE PURPOSE SECTION 14, PARAGRAPH (H) AND
SECTION 29 OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS
“THE JUDICIARY REORGANIZATION ACT OF 1980”, AS AMENDED, AND
APPROPRIATING FUNDS THEREFOR.”**

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1.) “On Page 1, Section 1, line 1, insert the number “ONE” between the words “with” and “seat”;
- 2.) “On the same page, section and line, insert the word “EACH” after the word “seat”;
- 3.) “Still on the same page and section, lines 2 and 3, delete the phrase “and a branch of the Municipal Trial Court in Cities with seat at the City of Naga,”;
- 4.) “On the same page and section, lines 6-7, delete the phrase “and a branch of the Municipal Trial Court in Cities”;

- 5.) "On Page 2, Section 2, lines 4-5, delete the phrase "and a branch of the Municipal Trial Court in Cities at the City of Naga";
- 6.) "On the same page, Section 3, line 8, delete the phrase "and Section 29"; and
- 7.) The title is amended to read as follows:




