

#### MR. PRESIDENT:

#### "AN ACT

CREATING TWO (2) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT AND SIX (6) ADDITIONAL BRANCHES OF THE METROPOLITAN TRIAL COURT TO BE STATIONED AT THE CITY OF VALENZUELA, METRO MANILA, AMENDING FOR THE PURPOSE SECTION 14 (d) AND SECTION 27 OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED, AND APPROPRIATING FUNDS THEREFOR."

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1.) "On Page 1, Section 1, line 1, change the number "two (2)" to "FOUR (4)";
- 2.) "On the same page, section and line, change the number "six (6)" to "THREE (3)";
- 3.) "On Page 2, Section 2, line 6, change the number "two (2) to "FOUR (4)";

- 4.) "On the same page and section, line 7, change the number "six (6)" to "THREE (3)"; and
- 5.) The title shall be amended to read as follows:

### **"AN ACT**

CREATING FOUR (4) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT AND THREE (3) ADDITIONAL BRANCHES OF THE METROPOLITAN TRIAL COURT TO BE STATIONED AT THE CITY OF VALENZUELA, METRO MANILA, AMENDING FOR THE PURPOSE SECTION 14 (d) AND SECTION 27 OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED, AND APPROPRIATING FUNDS THEREFOR."
