PENALTIES THEREFOR"**


have considered the same and have the honor to report it back to the Senate with the recommendation that the attached bill, Senate Bill No. 3127 prepared by the Committee entitled:

PENALTIES THEREFOR AND FOR OTHER PURPOSES"**


