


**MR. PRESIDENT:**

The Committees on Public Works and Finance, to which was referred House Bill No. 1872, introduced by Representatives Escudero III and Solis, entitled:



AN ACT CONVERTING THE BACON -- SAWANGA -- PRIETO DIAZ  
ROAD IN THE CITY OF SORSOGON AND THE MUNICIPALITY  
OF PRIETO DIAZ, PROVINCE OF SORSOGON INTO A  
NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled.*

1           SECTION 1. The Bacon -- Sawanga -- Prieto Diaz Road in the City of  
2 Sorsogon and the Municipality of Prieto Diaz, Province of Sorsogon is hereby  
3 converted into a national road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5 Highways shall issue the necessary rules, orders and circulars to implement the  
6 provision of this Act.

7           SEC. 3. This Act shall take effect upon its approval.

Approved.
