



AN ACT CONVERTING THE ROAD WHICH STARTS FROM THE
ILIGAN - MARAWI NATIONAL HIGHWAY AT BALOI AND
TRAVERSES MATUNGGAO TO THE ILIGAN - AURORA
HIGHWAY AT LINAMON, PROVINCE OF LANA DEL NORTE
INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The road which starts from the Iligan - Marawi National
2 Highway at Baloi and traverses Matunggao to the Iligan - Aurora Highway at
3 Linamon, Province of Lanao del Norte is hereby converted into a national
4 road.

5 SEC. 2. The Secretary of the Department of Public Works and
6 Highways shall issue the necessary rules, orders and circulars to implement the
7 provision of this Act.

8 SEC. 3. This Act shall take effect upon its approval.
