1 SECTION 1. The Bato-Bato -- Lapid-Lapid Provincial Road in the
2 Municipality of Panglima Sugala, Province of Tawi-Tawi is hereby converted
3 into a national road.

4 SEC. 2. The Secretary of the Department of Public Works, and
5 Highways shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in a newspaper of general circulation.

4 Sec. 2. The Secretary of the Department of Public Works and Highways
5 shall issue the necessary rules, orders and circulars to implement the
6 provision of this Act.

7 Sec. 3. This Act shall take effect fifteen (15) days after its publication in
8 a newspaper of general circulation.
