

House Bill No. 4674, introduced by Representative Oscar G. Malapitan, entitled:



### AN ACT CONVERTING THE CONGRESSIONAL ROAD IN NORTH CALOOCAN CITY INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The congressional road in North Caloocan City is hereby  
2 converted into a national road.

3           SEC. 2. The Secretary of the Department of Public Works and  
4 Highways shall issue the necessary rules, orders and circulars to implement the  
5 provision of this Act.

6           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
7 in a newspaper of general circulation.
