
**MR. PRESIDENT:**

AN ACT CONVERTING THE PANIQUI – RAMOS ROAD IN THE  
MUNICIPALITIES OF PANIQUI AND RAMOS, PROVINCE OF  
TARLAC INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Paniqui – Ramos Road in the municipalities of  
2           Paniqui and Ramos, Province of Tarlac is hereby converted into a national  
3           road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5           Highways shall issue the necessary rules, orders and circulars to implement the  
6           provision of this Act.

7           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
8           in a newspaper of general circulation.
