





AN ACT CONVERTING THE SAN JOSE – MAYANTOC ROAD,  
PROVINCE OF TARLAC INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1       SECTION 1. The San Jose – Mayantoc Road which traverses along  
2       Lawac – Amulag – Sula via Villa Aglipay Road, Sula – Burgos Road, Tarlac  
3       City – San Clemente via Burgos Road and road to Bucot Baboy, Province of  
4       Tarlac is hereby converted into a national road.

5       SEC. 2. The Secretary of the Department of Public Works and  
6       Highways shall issue the necessary rules, orders and circulars to implement the  
7       provision of this Act.

8       SEC. 3. This Act shall take effect fifteen (15) days after its publication  
9       in a newspaper of general circulation.
