BY REPRESENTATIVES CASTELO, BELMONTE (F.), BANAL, HERRERA-DY AND
CRUZ-GONZALES, PER COMMITTEE REPORT NO. 665

AN ACT REAPPORTIONING THE SECOND (2ND) LEGISLATIVE DISTRICT OF QUEZON CITY, THEREBY CREATING TWO (2) ADDITIONAL LEGISLATIVE DISTRICTS AND TWELVE (12) SANGGUNIANG PANLUNGSOD SEATS FROM SUCH REAPPORTIONMENT

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Reapportionment of the Second Legislative District.* -- The
2 Second (2nd) Legislative District of Quezon City is hereby reapportioned in
3 order to create two (2) additional legislative districts to commence in the next
4 national and local elections after the effectivity of this Act.

5 In furtherance of the reapportionment mandated by this Act, the Second
6 (2nd) Legislative District of Quezon City is hereby reapportioned as follows:

7 SECOND (2ND) LEGISLATIVE DISTRICT:

- 8 (a) Barangay Bagong Silangan
9 (b) Barangay Batasan Hills
10 (c) Barangay Commonwealth
11 (d) Barangay Holy Spirit
12 (e) Barangay Payatas

- 1 FIFTH (5TH) LEGISLATIVE DISTRICT:
- 2 (a) Barangay Bagbag
- 3 (b) Barangay Capri
- 4 (c) Barangay Greater Lagro
- 5 (d) Barangay Gulod
- 6 (e) Barangay Kaligayahan
- 7 (f) Barangay Nagkaisang Nayon
- 8 (g) Barangay North Fairview
- 9 (h) Barangay Novaliches Proper
- 10 (i) Barangay Pasong Putik Proper
- 11 (j) Barangay San Agustin
- 12 (k) Barangay San Bartolome

- 16 SIXTH (6TH) LEGISLATIVE DISTRICT:

1 The composition of the current First (1st), Third (3rd) and Fourth (4th)
2 Legislative Districts of Quezon City shall not be affected by the
3 reapportionment mandated by this Act.

4 SEC. 2. *Sangguniang Panlungsod.* – In accordance with the
5 reapportionment mandated by this Act, there shall be elected in the next
6 national and local elections after the effectivity of this Act, six (6) regular
7 Sangguniang Panlungsod members representing each of the Fifth (5th) and
8 Sixth (6th) Legislative Districts of Quezon City.

9 SEC. 3. *Incumbent Representative and Sangguniang Panlungsod*
10 *Members.* – The incumbent Representative and Sangguniang Panlungsod
11 members of the Second (2nd) Legislative District of Quezon City shall continue
12 to hold office until the new Representatives and Sangguniang Panlungsod
13 members shall have been elected and qualified.

14 SEC. 4. *Implementing Rules and Regulations.* – The Commission on
15 Elections shall issue the necessary rules and regulations to implement this Act.

16 SEC. 5. *Repealing Clause.* – All laws, rules and regulations which are
17 inconsistent with this Act are hereby repealed, amended or modified
18 accordingly.

19 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after
20 its publication in any newspaper of general circulation.
